- A global perspective on industry issues and concerns (attends/participates in national/state/local industry conferences and meetings)
- The ability to work collaboratively and engage in appropriate debate and discussion
- Committed to attending bi-monthly and special meetings of the NEXUS Board of Directors

#### How do you apply?\*

The election process will take place in accordance with <u>Article XI, Section 4</u> of the Nexus Association of REALTORS<sup>®</sup> Bylaws. For the 2026 cycle, the President-Elect position and two 3-year Director positions are available.

### Timeline

- June 27: Deadline to submit application/letter of interest
- July 16 (and 17, only if needed): Nominating Committee interviews candidates
- August 18: Slate of candidates selected by Nominating Committee posted on Association website no later than this date
- **October 23**: Annual Election (if required)
