



PETITION TO ADD ADDITIONAL CANDIDATE TO THE BALLOT FOR BOARD OF DIRECTOR NOMINATIONS

[Article XI, Section 4](#) of the NEXUS Association of REALTORS® Bylaws provides that: “Additional candidates for the offices to be filled may be placed in nomination by petition on a form approved by the board of directors signed by at least 10 % of the REALTOR® members eligible to vote. The petition shall be filed with the Chief Executive Officer at least thirty (30) days before the election. The Chief Executive Officer shall send notice of such additional nominations to all members eligible to vote before the election.”

This document is the only official petition in the form that was approved by the Board of Directors on July 16, 2024. Signatures obtained in another fashion or on another ballot will not be accepted by the Board of Directors.

Instructions:

- 1) Each petition must be completed and signed by 10% of the REALTOR® members eligible to vote. As of August 8, 2025, the National Association of REALTORS® reflects an eligible membership of 5,780, therefore **a minimum of 578 signatures are needed for each additional candidate to be placed in nomination.**
- 2) Candidates must complete the informational portion of the form PRIOR to obtaining signatures from members. The entire document, including page 1, must be included with each request for a signature.
- 3) Candidate must indicate which single position they are seeking.
- 4) Printed names must be legible. Illegibly printed names will not be counted.
- 5) **All petitions with original signatures (no copies) must be delivered in person to the attention of the NEXUS Association of REALTORS® CEO and received at the Association office by 4:30 p.m. on Tuesday, September 23, 2025.**
