- Committed to attending bi-monthly and special meetings of the NEXUS Board of Directors

The election process will take place in accordance with [Article XI, Section 4](#) of the Nexus Association of REALTORS® Bylaws. For 2027, the President-Elect position, Treasurer position, and two 3-year Director positions are available.

## Timeline

- **June 26:** Deadline to submit application/letter of interest
- **July 15 (and 16, only if needed):** Nominating Committee interviews candidates
- **August 14:** Slate of candidates selected by Nominating Committee posted on Association website no later than this date
- **October 15:** Annual Election (if required)
